




Low Education attainment in some countries







- 1. Systemic VET reform expertise (governance, financing, provision, teacher education & training, school management, curriculum & standards, LLL etc.)
- 2. Links with the labour market (cooperation with employers, PPP, work based learning, skills matching and anticipation, career guidance & counselling, employability, youth employment, LMIS etc.)
- 3. Capacity to contextualise knowledge and expertise in a new environment
- 4. Tools, methods, hands-on & innovative solutions
- 5. Language skills (English but not only Russian, French, etc.)
- 6. EU member states practices (portfolio/menu of approaches)
